The Hon. Bill Shorten MP speaks at IDAS launch

UnitingCare West and Sussex Street Community Law Service Inc. will be joined by the Hon Bill Shorten MP, Parliamentary Secretary for Disabilities and Children on Thursday 22nd July to officially launch the new Individual Disability Advocacy Service (IDAS).

IDAS is a free, independent and confidential support service for people with disabilities, their family members and carers. This free service is available to the North West Metropolitan Areas including Cities of Wanneroo, Joondalup, Stirling and Towns of Cambridge and Vincent. It can help in accessing rights to services, education, transport, sport and recreation, housing, financial matters, employment or any other issues. The IDAS team also deals with issues of discrimination, abuse and neglect.

Chris Hall, UnitingCare West Chief Executive Officer "IDAS is a world-class service here in our own community. The advocates are well-trained professionals and are doing an excellent job."

Naomi O'Donnell (Advocate) "Anyone can be an advocate. It's about people being treated well, being respected and listened to. We're here to help speak for those who need to be heard, and that's everyone's responsibility really. I'm just fortunate enough to do this full time."

Sussex Street Community Law Service is a community based and managed not for profit legal practice. The organization has been providing legal and social services to the community since 1978. Sussex Street's core activities are casework, community legal education, and law and legal policy reform in the areas of family civil and minor criminal law, Welfare Rights (Centrelink matters), tenancy, financial counseling and disability discrimination and disability advocacy.
